INSTRUCTIONS FOR SMOOTH VC HEARINGS

- Upon clicking the "Join" button, the party would be prompted to enter the display name wherein the party is required to write his/her name with designation by prefixing item no. (of the cause list) in the space given i.e.: ITEM NO. 1 ABC Appellant OR ITEM NO. 1 DEF Respondent OR ITEM NO. 1 GHI PARTY-IN-PERSON, as the case may be, and thereafter the party is required to click on the "JOIN" button.
- 2. After joining, ensure that VIDEO is always on OFF mode AND MIC is always on MUTE mode.
- 3. Video should be switched ON only by the Counsel for the parties/litigants to a case, when the concerned Item No. is called for hearing Mic should be UNMUTED only by the party speaking.
- 4. One device each should be used by the respective Parties.
- 5. Switching On the Video or UNMUTING the Mic otherwise will disturb the hearing of ongoing matters.
